

**IF YOU WERE A MEMBER AT A MESSAGE ENVY® FRANCHISE AT ANY TIME  
BEFORE JUNE 30, 2016, A CLASS ACTION SETTLEMENT MAY AFFECT YOU**

**The sole purpose of this notice is to inform you of the settlement so that you may decide what to do.**

**Records indicate that you were a member of a Massage Envy® Franchise before June 30, 2016, and that you may have previously received notice of a proposed settlement as a class member in a lawsuit entitled *Hahn v. Massage Envy Franchising, LLC*. PLEASE READ THIS SUMMARY NOTICE AND THE FULL VERSION OF THIS NOTICE AVAILABLE AT THE WEBSITE BELOW CAREFULLY – YOUR RIGHTS AND THE BENEFITS TO WHICH YOU MAY BE ELIGIBLE HAVE CHANGED**

A proposed settlement has been reached in the nationwide class action lawsuits, *Donna Zizian, v. Massage Envy Franchising, LLC*, Civ. No. 16-CV-00783 and *Michelle Bandell et al. v. Massage Envy Franchising, LLC* Civ. No. 16-CV-01236 GPC-BGS. These lawsuits challenge provisions in membership agreements used by Massage Envy® franchised locations impacting members' ability to use accrued massages after membership termination, cancellation or nonrenewal. Massage Envy Franchising, LLC denies all allegations. These lawsuits were filed and this settlement ("Zizian Settlement") was reached after the Court denied final approval of a proposed settlement in the related lawsuit entitled *Hahn v. Massage Envy Franchising, LLC*. The Court sent you this notice because you have a right to know about the Zizian Settlement and all your options before the Court decides whether to approve it. You are a Class Member if either:

- Your membership at a Massage Envy® Franchise within the United States was cancelled, terminated for non-payment, or not renewed between March 7, 2015, and June 30, 2016, and you have at least one accrued unused 50-minute member massage ("Cancelled Members"); or
- You were an active member of a Massage Envy® Franchise within the United States as of June 30, 2016, if your account was current, suspended or frozen, and had not been cancelled, terminated or not renewed ("Active Members").

The Court will exclude from the lawsuits any Class Member who requests exclusion.

If you are a Cancelled Member, you may submit a request for reinstatement of approximately 75% of your accrued unused massages. **EVEN IF YOU PREVIOUSLY SUBMITTED A REINSTATEMENT REQUEST FOR THE HAHN SETTLEMENT, YOU MUST SUBMIT ANOTHER REINSTATEMENT REQUEST TO RECEIVE YOUR REINSTATED MESSAGES.**

If you are an Active Member, and the Zizian Settlement is approved and you don't exclude yourself, you will automatically receive 60 days following membership termination, cancellation or nonrenewal to use or transfer all accrued unused massages under the terms of your membership agreement. Alternatively, if you are an Active Member, you may elect instead to receive a 180-day period after membership termination, cancellation or nonrenewal to use 75% of accrued unused massages, but they cannot be transferred and must be used by you at your Home Clinic. If you elect the 180-day period, you will have a one-time opportunity under the Zizian Settlement to choose a new Home Clinic at the time you make this election. The Zizian Settlement does not provide for a refund of any unused massages or any other monetary relief. You may also choose to exclude yourself from or object to the Zizian Settlement with the option to appear at the January 13, 2017 final approval hearing. Attorneys have been appointed to represent the Cancelled Members and the Active Members at the hearing. However, if you prefer, you may attend the hearing or have your own attorney appear on your behalf and at your own expense.

You may submit a request for reinstatement or an election of benefit by using the Unique ID listed on the front of this postcard.

If you do nothing you will be bound by the terms of the Zizian Settlement and cannot later sue on your own behalf. If you exclude yourself, you will not receive anything from the Zizian Settlement, but will retain your right to sue on your own behalf. All reinstatement requests, election of benefit forms, requests to be excluded from the Zizian Settlement, and written objections to the Zizian Settlement must be submitted by October 18, 2016.
